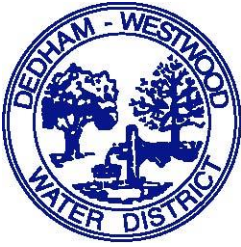




Water Conservation Rebate Program Policy

- The applicant must be a residential or commercial customer with an existing, non-delinquent account receiving water service from the Dedham-Westwood Water District.
- Rebates will be issued in the form of a water account credit.
- Receipts for toilets/washing machines **must not be more than six months old.**
- **Applicants that do not submit the required proof of purchase (bill or receipt that includes the make, model, and, if applicable, water factor) will automatically be rejected.**
- The District reserves the right to conduct a site visit to verify installation at the said property before processing the rebate.
- The District reserves the right to change or discontinue this program without notice.
- The program is contingent upon available funding each calendar year.
- Rebates are available on a first-come, first-serve basis.
- **Residential Customers Are Eligible to Receive:**
 - Two (2) toilet rebates *per the lifetime of the property*
 - One (1) washing machine rebate *per property every seven years*
- **Commercial Customers Are Eligible to Receive:**
 - Two (2) toilet rebates *per the lifetime of the property*
- **Toilet Replacement Requirements:**
 - Replace an existing older model toilet with a high-efficiency toilet that uses 1.28 gallons of water per flush or less for a dual flush model. High-efficiency toilets carry the [WaterSense](#) label.
 - **The bill/receipt for the fixture must include the toilet make and model. This information must be submitted with your application.**
- **Washing Machine Requirements:**
 - The machine must be front-loading, or top loading AND have a Water Factor of 4 or less.
 - **The bill/receipt for the machine must include the washer make, model, and water factor. This information must be submitted with your application.**

The maximum number of toilets eligible for rebate is two per property (commercial or residential). The frequency of the washer rebate is once every seven years per residential property. I understand that my water account must not be past due, and my water meter will be replaced if requested by the District (no charge for this) before a rebate credit will be issued.

I agree to indemnify and hold harmless and defend the District and all of its commissioners, officers, agents, employees, or authorized representatives from any claims, suits, actions, losses, or liability of every kind, nature, and description, including but not limited to, the delivery, installation, product malfunction, plumbing malfunction, maintenance or use of toilets or washing machines purchased through this program.
