The following additions and/or alterations to the plans and specifications for the above-referenced contract are to be incorporated into all general bids for the proposed work.

Inclusion of this Addendum must be acknowledged by inserting the addendum number and date in The Form for General Bid, page 00300-1 of the specifications. The Addendum must also be acknowledged in the Contract Agreement, Article 7, paragraph 7.01.12, page 00510-3 of the specifications upon execution of the Contract Agreement. Failure to acknowledge any and all addenda in the Form for General Bid may be cause for rejection of the bid by the OWNER on the grounds that it is not responsive to the "INFORMATION FOR BIDDERS."

## SPECIFICATIONS:

1. Reference Division 00, Specification Section 00030 Advertisement for Bids, page 00030-1:  
Replace the following paragraph:

“The Dedham-Westwood Water District shall receive General Bids at the Dedham-Westwood Water District office, 50 Elm Street, Dedham, Massachusetts 02026 for the Construction of the White Lodge Water Treatment Plant Aeration Tower Media Replacement, Contract No. 4, until 10:00 AM prevailing time, Thursday, August 15, 2024, at which time bids will be opened and publicly read aloud. Bids submitted after this time will not be accepted. A pre-bid conference will be held on Wednesday, August 7, 2024, at 10:00 AM at the White Lodge Treatment Plant, 154 University Avenue, Westwood, MA 02090.”

With:

“The Dedham-Westwood Water District shall receive General Bids at the Dedham-Westwood Water District office, 50 Elm Street, Dedham, Massachusetts 02026 for the Construction of the White Lodge Water Treatment Plant Aeration Tower Media Replacement, Contract No. 4, *until 10:00 AM prevailing time, Thursday, August 22, 2024*, at which time bids will be opened and publicly read aloud. Bids submitted after this time will not be accepted. A pre-bid conference will be held on Wednesday, August 7, 2024, at 10:00 AM at the White Lodge Treatment Plant, 154 University Avenue, Westwood, MA 02090.”

2. Reference Division 00, Specification Section 00300, Form for General Bid. Delete the section in its entirety, and replace with Attachment 1, included in this Addendum: Revised Form for General Bid
3. Reference Division 01, Specification Section 01025, Measurement and Payment, page 01025-3, Paragraph 2.07, Delete in its entirety, and replace with:

“2.07      ITEM NO. 6      AERATION TOWER EXHAUST AIR DUCT REPLACEMENT

- A. Payment shall be made at the unit price bid per linear foot for Bid Item No. 6 in the bid form and shall constitute full compensation for furnishing all labor, materials, tools, and equipment necessary to complete the Work, as required by the Contract Documents. The price shall include but is not necessarily limited to removal and proper disposal of the existing ductwork, replacement of existing galvanized ductwork in-kind prior to heating coils as shown on Sheet HP-2A in Appendix B, and coordination with all parties to ensure that one tower shall always remain in service”

4. Reference Division 01, Specification Section 01100, Measurement and Payment, page 01100-3, Paragraph 3.09, Delete in its entirety, and replace with:

“3.09 EXHAUST DUCT REPLACEMENT

- A. Aeration tower exhaust duct replacement shall be coordinated with the media removal and replacement so that one tower shall always remain in service.
- B. Replace existing galvanized ductwork in-kind prior to heating coils as shown on Sheet HP-2A in Appendix B.

Bidder further agrees to pay as liquidated damages, the sum of \$1,300 for each consecutive calendar day thereafter.

Bidder understands that Owner reserves the right to reject any or all bids, to waive any informalities in the bidding or to reduce the scope of the Work to stay within budget restraints. Bid security in the form of a bid bond, cash, certified check, treasurer's or cashier's check payable to Owner, in a dollar amount of 5 percent of the total bid, in accordance with the conditions in the Instructions To Bidders, has been attached to this bid. The Bidder agrees that this bid shall be good and may not be withdrawn for a period of 60 calendar days after the actual date of opening thereof.

Upon receipt of written notice of the acceptance of this bid, Bidder will execute the formal contract attached within 5 days (Saturdays, Sundays and legal holidays excluded) and deliver a Surety Bond or Bonds as required by ARTICLE 5 of the General Conditions. The Bid Security attached is to become the property of Owner, in the event the Contract and Bond are not executed within the time above set forth, as liquidated damages for the delay and additional expense to the Owner caused thereby.

The undersigned hereby certified that he is able to furnish labor that can work in harmony with all other elements of labor employed or to be employed on the work; that all employees to be employed at the worksite will have successfully completed a course in construction safety and health approved by the United States Occupational Safety and Health Administration that is at least 10 hours in duration at the time the employee begins work and who shall furnish documentation of successful completion of said course with the first certified payroll report for each employee, and that he will comply fully with all laws and regulations applicable to awards made subject to section 44A.

The undersigned further certifies under the penalties of perjury that this bid is in all respects bona fide, fair and made without collusion or fraud with any other person. As used in this subsection the word "person" shall mean any natural person, joint venture, partnership, corporation or other business or legal entity. The undersigned further certifies under penalty of perjury that the said undersigned is not presently debarred from doing public construction work in the Commonwealth under the provisions of Section twenty-nine (29) F of Chapter twenty-nine (29) or any other applicable debarment provisions of any other Chapter of the General Law or any rule or regulation promulgated thereunder M.G.L. c.149, ss. 44E(2) and 44F(2). Pursuant to MGL 62C, Section 49A, I certify under the penalties of perjury that I, to my best knowledge and belief, have filed all State Tax Returns and paid all State Taxes required under Massachusetts General Laws.
